In consideration of Angel Lane my/our pet(s) the undersigned agrees and represents as follows:

	To pay Angel Lane Boarding the total accrued for each night my pet(s) is/are boarded. The total for their stay will be determined by what time I pick them up on their last day. (Pick up before 11 am is free, after is \$25 daycare charge) Initial
2.	I represent my pet(s) is/are free of all diseases and has/have had all required shots and vaccinations (DHLPP, RABIES, BORDETELLA). I further understand and agreed that in admitting my pet(s) to Angel Lane Boarding, Angel Lane Boarding has relied on my representation that my pet(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. 3.	To supply all food/medicine which may be necessary during the term the pet(s) is boarded. If your dog runs out of food, or you forget their food, a \$50 charge plus the cost of the food will be applied to your final bill. Please be sure to pack the right amount of food, plus extra, incase you are delayed on your trip. Initial
4.	In case there is an emergency, and I cannot be reached I authorize you to contact the emergency contact I have given to make decisions on the care of my pet(s). If the person cannot be reached; the undersigned leaves it to the discretion of Angel Lane Boarding to respond to the emergency and the undersigned agree to be responsible for ANY AND ALL CHARGES INCURRED. 5.	To be solely responsible for any harm caused to or by my pet(s) while my pet(s) is/are boarded				
	at Angel Lane Boarding. I understand the risk(s) of placing my dog(s) in a setting with				
	multiple dogs at a time and that it is my responsibility to fully research these risks. These risks				
	include but are not limited to: nips, bites, scratches, illness, injury, allergies, or stress related illness				
	(diarrhea, dehydration, UTI's). etc. I understand that while Angel Lane Boarding screens all				
	of their guests, dogs are still animals, and that by having multiple dogs together, accidents can happen and				
	illnesses can occur. It is my choice to place my dog in that type of environment. I understand I am				
	solely financially responsible for any veterinary care, for any reason, needed during or after their				
	stay.
